

RULES FOR PROVIDING THE "SUBSCRIPTION TO brainergpt.ucom.am" SERVICE
TO THE SUBSCRIBERS OF "UCOM" CJSC

The present provisions (hereinafter referred to as the "Rules") shall be considered mandatory and are set out in these rules for the provision of the "SUBSCRIPTION to brainergpt.ucom.am" service (hereinafter referred to as "Subscription") to the subscribers of "UCOM" CJSC (hereinafter referred to as the "Subscriber").

1. Any individuals who have reached the age of 18 and are Subscribers of "UCOM" CJSC telecommunication operator (hereinafter referred to as the "Operator") may use the "Subscription" service on "brainergpt.ucom.am" Internet resource under the terms and conditions specified below.
2. To order the "Subscription" service, the Subscriber must have the equipment necessary to place the order and use the service, including, but not limited to a mobile phone (or other mobile access device) that is in proper working order and supports access for the Subscriber to the Operator's services by connecting this terminal equipment to the Operator's network.
3. The Subscriber shall order the "Subscription" service using the "brainergpt.ucom.am" Internet resource (hereinafter referred to as the "Resource") through the Operator's telecommunication services by pressing the subscription button (e.g., "Watch", "Listen", "Download", "Subscribe", etc. (and not limited to)). When providing the "Subscription" service, various methods may be used to attract Subscribers to order the service, including, but not limited to, banners, teasers, and redirects.
4. By ordering the "Subscription" service in the manner prescribed in Clause 3 of the Rules, the Subscriber:
 - 4.1. confirms that he/she has read and agrees with the Rules;
 - 4.2. confirms his/her consent to receive the "Subscription" service in accordance with the terms and conditions set out in the Rules;
 - 4.3. confirms the fact of fulfillment of all requirements put forth before the Subscriber by the Rules, as well as undertakes to follow these requirements during the period of use of the "Subscription" service;
 - 4.4. gives consent to receiving free SMS messages from 9545 short number for Subscribers of Ucom CJSC, informing the Subscriber about the fact of connection and the terms of provision of the "Subscription" service;
 - 4.5. performance by the Subscriber of the actions specified in Clause 4 of the Rules shall mean a consent of the Subscriber to receive the Content service in accordance with the terms

and conditions stated by the Operator and to receive the Subscription to Content selected by the Subscriber.

5. As part of the “Subscription” service, the Subscriber receives possibility to access sections and/or functionality of the Resource.

After the Subscriber has completed the actions specified in Clause 3 of the Rules, the “Subscription” service starts to be provided on a paid basis. The fact that the service has started to be provided shall be confirmed by an SMS message sent to the Subscriber from 9545 short number upon the first charge. On the first day, the service shall be provided free of charge (only upon first activation), afterwards - AMD 99 (including VAT) per 1 calendar day. When renewing the “Subscription” service, the free period of one day shall not apply. Internet traffic tariffs are paid by the Subscriber additionally based on the Operator's tariffs. In the event the amount fails to be charged from the Subscriber's account, attempts to renew the “Subscription” shall be made daily for 30 days. If the amount fails to be charged within that period, the “Subscription” shall be considered cancelled.

6. The subscriber shall have the right to cancel the “Subscription” service at any time by sending an SMS message with the word "STOP" to 9545 short number. Access to the functionality shall be maintained until the end of the period paid.
7. When reconnecting the service, you shall have to again perform the actions specified in Clause 3 of the Rules.
8. These Rules are a public offer to conclude an agreement on the provision of the “Subscription” service on the terms and conditions set out above. The Operator shall have the right to unilaterally amend the Rules by publishing the new edition on the Resource.

9. The relationship between the Operator and the Subscriber shall be regulated by the General Terms and Conditions for Provision of Electronic Telecommunication and other related services, which are published on the official website of the Operator: <https://www.ucom.am/terms-and-conditions> .

10. RESTRICTION OF LIABILITY

The operator shall not be held liable in cases of occurrence of problems/errors in the software and/or hardware of the Subscriber's mobile equipment and browser, as a result of which the Service is ceased, restricted, or Services are not provided fully and/or properly.

The Subscriber acknowledges and agrees that the Operator shall not be liable (including under contractual obligations) for any direct, indirect, incidental or punitive losses that the Subscriber may incur as a result of using the content downloaded through it.

The Operator shall not be liable for damage caused to the Subscriber as a result of spam, hacking, or transmission of viruses.

The Operator shall not be held liable for any form of advertising and/or banner advertising, pop-up windows and any other advertising formats that are presented on the website and in the application. The advertiser or its legal representatives bear full responsibility for such content.

The Operator shall not be liable for disputes and disagreements between the Subscriber and a third party related to the use of the Resource.
